THE CHALLENGE

Achieving net zero requires the power sector to deliver around 60% of global energy-related CO₂ emission reductions. This transition must go hand in hand with closing energy access gaps through both utility-scale and decentralised **green and clean energy** solutions.

While the need for **power sector transformations** is widely recognised, the institutional, regulatory, and technical environment to initiate change and trigger investment is often limited or yet to be built.

THE APPROACH

GET.transform supports power sector transformation by placing **regulatory reform** and capacity development at the centre of change. The programme strengthens **frameworks and professional skills**, enabling institutions to design and implement effective policies that foster a **conducive investment climate** leading to a pipeline of bankable clean energy projects.

Operating globally with a focus on **Africa and Latin America and the Caribbean (LAC)**, the programme uses a systematic approach in advancing power sector transformations with national or regional partners:

- Targeted advisory services addressing key energy transition challenges
- **Scaling-up** and mainstreaming **country** and **regional best practices**
- **Cost-efficient implementation** through standardised approaches
